Aim of Activity \*

To support people, 18 years+, with severe mental illness and associated psychosocial functional impairment who are not supported through the NDIS.

To reduce the avoidable need for acute health services and reduce crisis-driven use of the health care system.

#### **Description of Activity \***

1. Service Delivery

In partnership with ACT Health and in alignment with NPS guidance material, ACTPHN will commission psychosocial services. In 2018, a process was undertaken to co-design a set of outcomes with the community and procurement was undertaken, identifying

two successful providers. These providers will continue the delivery of psychosocial services through this activity period.

Psychosocial supports will focus on addressing a range of issues including:

- · social skills and friendships;
- family connections;
- managing daily living needs;
- financial management and budgeting;
- finding and maintaining a home;
- vocational skills and goals, including volunteering;
- educational and training goals;
- maintaining physical wellbeing, including exercise;
- managing drug and alcohol addictions, including tobacco; and
- building broader life skills including confidence and resilience.

The commissioned service providers will work with clients to address these issues through:

- Providing early intervention support services to people with severe mental illness between 18-64 years that do not meet the NDIS threshold.
- Development of Individual Recovery Plans
- Evidence-based services including individual and group services
- Integration with primary and acute services
- Peer worker support

Both service providers will also continue to ensure integration across primary and acute mental health services to ensure that these non-clinical supports are contributing to better health outcomes.

With carry forward funding, ACT PHN has increased capacity to the service providers to increase services with a focus on emerging needs as a result of the COVID19 pandemic as well as evaluate the service in a local context following the outcomes of the national evaluation by NOUS.

To ensure continuation of support for people with severe mental illness and associated psychosocial functional impairment who were previously accessing Partners In Recovery (PIR), Day to Day Living (D2DL), or Personal Helpers and Mentors (PHaMs) as they test for the NDIS and/or transition to ongoing services through the NDIS or Continuity of Supports.

#### **Description of Activity \***

In alignment with Department of Health guidance, ACT PHN will contract the current community providers of D2DL, PHaMs, and PIR to continue providing supports for an additional 12 months to current, active clients for D2DL, PHaMs, and PIR. This will include:

- -Evidence based individual and group-based services
- -Support facilitation
- Support in testing eligibility for the NDIS and transitioning to ongoing support through NDIS or Continuity of Supports.

ACT PHN will work with service providers to establish safe transition pathways between services.
