To commission specialist AOD counselling services, provided by suitably experienced registered clinicians with AOD experience which is supported by case management.

Description of Activity *

Primary objectives of AOD treatment are:

- To reduce the client's level of substance use
- To reduce the client's experience of AOD related harm
- To build the client's capacity to better understand and manage their own health and wellbeing.

Achieving these objectives is largely associated with more positive outcomes and sustained reductions in AOD related harms and use. Long-term treatment success is more common with longer treatment duration and associated with the more intensive structured treatment modalities (e.g. counselling).

To deliver this activity, ACTPHN has commissioned a range of service providers to deliver counselling and case management services across the ACT PHN including the triage and comprehensive alcohol, tobacco, and other drug assessments and:

- Mental health screening
- Brief intervention
- Suicide risk assessment
- Screening for family violence
- Individual treatment plans
- Routine use of validate screening measures
- Evidence based psychological interventions

Funding has been provided to existing service providers to increase service delivery capacity, along with collaborative work with ATODA and the sector, to build the capacity of service providers to deliver high quality services through a series of capacity build and training projects.

A significant proportion of the population in mainstream drug and alcohol services in the ACT identify as Aboriginal or Torres Strait Islander. The ACT PHN needs assessment has identified the need for culturally appropriate mainstream services.

ACT PHN funds a mainstream drug and alcohol service, with extensive experience in delivering culturally appropriate care to Indigenous clients. These services have a focus on the provision of culturally appropriate case management for people waiting for residential rehabilitation services and people exiting residential services that require ongoing case management support. The service increases access to appropriate specialist counselling services and other interventions that may be required.

Aim of Activity *

The WSS specifically aims to deliver non-residential drug withdrawal services for people (with low to moderate withdrawal needs) connected with specialist alcohol and other drug (AOD) services, living in the Australian Capital Territory (ACT) prior to entry into an ACT specialist residential rehabilitation program.

Description of Activity *

The Withdrawal Support program is a nurse-led program that will:

- 1. Address the increased demand for access to drugs and alcohol treatment services.
- 2. Support region specific, cross-sectoral and integrated approaches, based on needs to clients locally, and focused on improving coordination at the local level.
- 3. Facilitate and support evidence-based treatment for clients using a range of substances.
- 4. Promote linkages with broader health services, including mental health services, to better support integrated treatment and referral pathways to support clients with comorbid mental disorders.
- 5. Ensure targeted and cultural appropriate drug and alcohol treatment services for Aboriginal and Torres Strait Islander people, that are linked with broader Indigenous health services; and
- 6. Promote quality improvement approaches and support health professional through education and training

The service will be delivered by a team of 3FTE of AOD nurses and supported by a Clinical Lead. A Reference Group will also be established to support delivery of the service and inform an evaluation approach.
