Statement in support of nomination

I am running for election to the CHN board as I am passionate about strengthening primary healthcare, improving health equity, and ensuring a sustainable workforce for the ACT community. I live in Canberra, teach medical students and research primary care at the ANU, bring strategic and governance experience, and work as a GP in the Canberra region.

Representing healthcare workers, driving strategic planning, and delivering change are roles I have held for many years. Arriving in Canberra from Scotland in 2018, I have held positions in Canberra Health Services including in emergency, rehabilitation, and non-clinical roles. At CHS I reviewed interdepartmental communications, was the Senior Medical Lead on the CHS Clinical Learning and Teaching Strategy, and worked closely with senior executives.

I am the President of General Practice Registrars Australia (GPRA), representing 20,000 members from medical students to newly fellowed GPs. I set strategic direction with the board, advocate to federal and jurisdictional governments, deliver education sessions, and most importantly listen to our members. As a director I would seek to hear from you to ensure your voice is heard. I represent GPRA on national committees including the GP Training Advisory Committee, the ACT and NSW Workforce Planning and Prioritisation Program (led by CHN), and the National Multidisciplinary Primary Care Research, Policy and Advocacy Consortium.

As an international medical graduate with experience across health systems, a local GP, medical academic, and experienced board member, I will represent you and your colleagues at the heart of CHN.

Statement addressing the position requirements

I believe I would bring a relevant and useful skillset to the CHN board, along with perspectives informed by international healthcare system experience, local clinical and academic experience, and a background in governance and strategic thinking.

As President of General Practice Registrars Australia (GPRA), I lead the organisation's strategic direction with my board, and advise the federal Department of Health on GP pipeline reforms including pay parity, study leave, parental leave, and expanded training places. This work requires navigating complex stakeholder engagement across the sector. My research at ANU focuses on the factors influencing prevocational doctor career choices closely aligning with my GPRA role and the CHN-led ACT and NSW Workforce Planning and Prioritisation Program. I have shown the ability to analyse complex data, balance perspectives within system contexts, and set clear direction.

Leadership has been essential in my elected role as GPRA President. I represent 20,000 members and speak on their behalf to stakeholders including government and politicians. I have been involved in negotiating the terms and conditions for GP registrars, have been invited to speak at national conferences, and always ensure my advocacy and leadership are informed by our members' views and stories. At CHS I led reviews into the hospital-wide huddle where departments communicate daily, sat on executive committees, developed the Clinical Learning and Teaching Strategy, and worked with senior executives on many projects. I currently hold positions on the RACGP NSW & ACT Faculty, Canberra Region Medical Education Council (the accrediting body for prevocational rotations in our region), and previously served on British Medical Association committees. Most of my board and committee experience has been through elected positions, reinforcing the importance of integrity and trust my colleagues place in me.

My governance experience spans domains including financial management, strategic planning, workforce and HR, and a strong familiarity with the responsibilities of a director and representative. At ANU I lead a research grant - managing my team and our finances, at GPRA I am a member of the Finance and Risk Management Committee, and previous director experience in the UK included my Students' Association Board with a turnover exceeding \$6 million and redevelopment planning over \$25 million. I have been mentored by peers with significant senior governance experience, and I plan to complete the AICD Company Directors Course within the next year (the flagship course for board directors).

I bring the combined perspective of a frontline GP, an academic, and a national medical leader. My experience spans clinical practice, workforce advocacy, and health policy, giving me a comprehensive understanding of both community needs and system-level challenges. I have a deep commitment to and connection with the ACT, our people, our workforce, and our healthcare system.
