Statement in support of nomination

Lewching (She/her) is a lived and living experience advocate, shaped by her experiences as a queer woman of colour and first-generation migrant who navigated systems, her safety, and her recovery as a survivor of family violence and complex trauma. Lewching's advocacy is centred around intersectionality and cultural safety for her communities. For the past 7 years, Lewching has partnered with governments and not-for-profits on state and national levels to drive systemic reforms, organisational governance, and co-design seeking to embed lived and living experience expertise at all levels. Outside Lewching's systemic advocacy, she has a background in frontline service provision across youth mental health, youth homelessness, suicide prevention, and domestic, family, and sexual violence. Lewching is the deputy chair at ACT Mental Health Consumer Network and an inaugural member of Lived and Living Experience Authority at Wellways Australia. Lewching is passionate about decolonizing systems and services to promote cultural safety across mainstream supports for culturally and racially marginalised communities.

Statement addressing the position requirements

Lewching brings lived experience leadership into governance to ensure strategic direction do not lose sight of the very individuals and communities that organisations like Capital Health Network seeks to work alongside. Lewching's work is led by peer values of mutuality, authenticity, human rights, and anti-oppression. - Relaying these court outcomes to people subjected to violence, safety planning with them, and advocating for them with the director of public prosecutions and courts.

CASE MANAGER, AUSTRALIAN RED CROSS – HUMANITARIAN SETTLEMENT PROGRAM (PLACEMENT)

- Provide ongoing case management for refugees and humanitarian entrants with the initial 12-18 months of their settlement into Australia.
- Utilize strengths-based approaches to assist clients in identifying their short- and long-term settlement goals.

SUICIDE PREVENTION PEER WORKER, STRIDE MENTAL HEALTH

NOV 2021 - FFB 2024

- Safe Haven functions as an after-hours suicide prevention crisis drop-in service. It serves as an alternative to the emergency department.
- Carry out brief interventions including psychosocial support, safety planning, recovery/wellness planning, sensory modulation techniques, and advocacy.
- Conduct risk assessment and support clients in transfer to the emergency department as required.

RESIDENTIAL YOUTH WORKER, YOUTH EMERGENCY ACCOMODATION NETWORK (YEAN)

OCT 2021 - AUG 2022

- Provide crisis accommodation for young people aged 16-25 facing homelessness and domestic family violence.
- Work across a 24-hour roster to provide ongoing support for these young people.

- Moderate online anonymous group chats to create safe and respectful online spaces for participants to provide and receive peer support. This includes ensuring safe language is being used in the chat and all participants abide by community guidelines.
