-Identify opportunities to improve access and support service delivery with a focus on: Service navigation and integration and referral pathways to other services that support a client's wellbeing and Improving access.

CHN procurement process will inform the commissioned services to be funded through to the current activity end date of 30 June

2027.

The CHN will support the current contracted service providers in a transitional period to 30 September 2025, to ensure continuity of service is maintained during procurement processes

Commissioning will aim to:

- Improve access and service delivery for short term, low intensity support
- Build capacity to improve service access and delivery

Focus will be on:

- Service navigation: working with service providers to support service navigation and referral pathways to other services that support a client's wellbeing;
- Improve intake and assessment process including use of standardised tools that validated and strengths-based
- Testing or re-testing for NDIS
- Assertive outreach; and exit strategies.

This also includes CHN operational costs to support this work.

To commission person-centred and recovery-focused psychosocial support services to support new and existing eligible consumers who are 18+ and are not more appropriately funded through the NDIS and are significantly affected by severe mental illness, which has impacted on their associated psychosocial functional capacity. These services, in partnership with families and carers (as appropriate) provide a range of non-clinical community-based support to support these individuals to achieve their recovery goals.

**Description of Activity \***

ACT PHN is working to support current commissioned service providers in a transitional period while procurement process is undertaken. The commissioning process will support providers to:

- Identify opportunities to improve access and support service delivery, and
- Build capacity within their teams to improve service delivery

This is accomplished through:

- Service navigation: working with service providers to support service navigation and referral pathways to other services that support a client's wellbeing
- Improving intake and assessment process including use of standardised tools that validated and strengths-based
- Testing or re-testing for NDIS
- Assertive outreach and exit strategies
- Providing a range of psychosocial supports including:

- Social skills and connections
- Day to say living skills
- Financial management and budgeting
- Finding and maintaining a home
- Vocational skills and goals
- Maintaining physical wellbeing
- Building life skills and resilience
- Reducing the avoidable need for more intense and acute health services and reduce unplanned or crisis-driven use of the health system.
