

- Support to participate in WIP-PS will be offered to general practices through direct engagement with the Quality Improvement team, development of a step-by-step guide/resource and educational events, if required
- Direct engagement with all general practices receiving WIP-PS to understand the primary health care professionals supported by WIP-PS at each practice, their model of care as well as any challenges and/or good news stories. Through this activity CHN will identify general practices with successful models of care and share their learnings through our various communication channels.
- Develop an information resource on all Practice Incentive Payments including the WIP-PS for use by general practices to reduce any gaps in knowledge about the incentive.
- Active collaboration with PHN Cooperative to share best practices, success stories and lessons learned.

CHN will identify eligible small or solo practices and Aboriginal Community Controlled Health Services (ACCHS) across the Canberra region and co-design a multidisciplinary approach to manage Diabetes. CHN will utilise data and practice engagement to support understanding of the practice needs and commission a Multidisciplinary team that will support practices identified. CHN will additionally work with Allied Health peak bodies for a baseline service model. There will be a co-design review among CHN,

selected practices, and commissioned MDT to offer free diabetes services (allied health) to patients at-risk of diabetic complications. CHN will also collaborate with providers such as the Diabetes ACT and CHS to determine pathways for self-management of patients enrolled in the program.

The aim of this activity is to provide access and links to primary health care services for vulnerable people who are often characterised by poor access and low engagement with primary health care services.

ACT PHN Needs Assessment identifies an ongoing need for in reach primary health care services to enable accessible and appropriate care to vulnerable people within the ACT, with identified target populations being people exiting the prison system, people living in supported accommodation and people at risk of homelessness.

Description of Activity *

In/out reach services are those that are delivered directly to the targeted community and may be effective in linking vulnerable groups to mainstream health care.

- Directions' integrated AOD primary care and counselling/case management outreach and in-reach services provide wrap around, responsive health care to vulnerable Canberra populations. The services utilise a drop-in arrangement, optimising practitioner time and the clinics' accessibility to clients. Clients have often not previously accessed health care for lengthy periods, despite having complex needs for many years prior to engaging with the service, due to stigma, previous negative help-seeking experiences and challenges navigating the health care system.
- The service also includes Pathways to Assistance and Treatment (PAT), Directions' mobile clinic. 'Chat to PAT' is a purpose built mobile clinic that provides wrap around support to marginalised Canberrans who can't easily access health services, including people who are homeless or experiencing severe disadvantages. This service is provided by a multi-disciplinary team which

includes GPs, nurses, counsellors and mental health practitioners. The team provides primary health care, mental health care, drug and alcohol support and case management. It also offers after hours service (5-9pm) one day per week.

- In 2024 - Outfitting of a second mini-Pat van was completed. This will enable Direction to offer more flexible mobile services to different locations and in the after hours period.

Continuation of this model of care will incorporate the findings from the initial evaluation to further support understanding of the return on investment associated with the model. CHN will also commission a provider to develop a comprehensive toolkit for general practices hiring social workers. The toolkit will provide clear practical guidance including workforce planning considerations, recruitment, onboarding, role descriptions, funding options, supervision and training frameworks, and integratation strategies and policies to suppport general practices through the end-to-end process of incorporating social work into their care teams and expand pilot to other general practices.
